Late Pick Up Fees/Late Payment Fee/Returned Payment I understand that a Late Pick Up Fee of \$2 PER MINUTE will be assessed for a Full Day child after 6:00PM or Half Day child after 12:00PM. The Late Pick Up Fees will be run on my ACH or credit card account attached to my account. Also, chronic late pick up of a child 7 or more times in a school year may result in termination of enrollment. If an ACH or credit card payment is returned for any reason, a \$25 Bounce Fee as well as the \$25 Late Fee per day will be assessed, if applicable. If a payment is late, the late tuition payment needs to be paid via credit card, cashier's check or money order. All other payments will be run using the method on my Brightwheel account. Cash is NOT accepted. Credit cards have an additional processing fee (check Brightwheel for more information). Chronic bounce fees of 2 or more times per school year may result in termination of the ACH payment option and possibly unenrollment.
